We are pleased to announce the 2017 HSCA Conference scheduled for Friday, February 10, 2017, from 7:45 a.m. to 3:00 p.m. at the Pomaika'i Ballrooms, 735 Iwilei Road, Honolulu, HI 96817.

The conference theme is **"E Kokua Ana I Na Haumana I Kulia I Ka Nu'u: Counseling Students to Strive for the Highest"**.

The keynote speaker will be Dr. Sherene McHenry, is a Licensed Professional Counselor with her Ph.D. in Counselor Education. She was a Counselor Educator for almost two decades and is passionate about helping counselors be more effective on a daily basis while avoiding burnout. Dr. McHenry will be presenting on school counselors and their roles with immediately implementable strategies counselors can use in school. She will also share stories and strategies for counselors to improve students' social/emotional development while helping them to strive to their fullest potential.

Following the keynote presentation, there will be three rounds of breakout sessions. The sessions will provide school counselors with assessment practices and interventions and strategies to use to enhance their school counseling programs.
